future of the U.S. Soil Survey and the NCSS... propagated by budget cuts and recent office closures... much of U.S. finished the initial survey (AK & West fed lands exception)... administrators never hear the word "initial" so we are finished in the eyes of many. We know there is much needed and valuable work to be done, but we need a clear vision of what is needed, how it can be accomplished, what new products will be produced, and what is the value of the products to management and conservation of the soil resource, i.e. why should funds be devoted to produce/improve a product that is available? This is a major issue that should be addressed by the NCSS and the regional conferences can be one opportunity to discuss the issue and solicit input. A potential scenario... prepare and distribute a short document highlighting the issue, describing potential soil survey activities and products for the next 10-20 years, and why these are important. This could be described in a short presentation early in the conference to be followed by a "town hall" meeting toward the end of the conference for those in attendance to discuss the issue and get input. This would be accompanied by opportunities for written input from all NCSS cooperators. The end product would be a blue print of where the soil survey would like to go in the next couple of decades, new information that would be gained, and the value of this information that could be used by all of us (NRCS and other federal agencies, states, universities, and others) to justify maintaining funds for the activity.
